

## Notes:

- 1. As the Company's business activity falls within a single significant primary business segment i.e. Jute Goods, no separate segment information is disclosed.
- 2. The above unaudited financial results after review of the Audit Committee were approved by the Board of Directors at their meeting held on 12th February, 2021.
- 3. The Statutory Auditors of the Company have carried out a limited review of the above unaudited financial results for the quarter and Nine Months ended 31st December, 2020 in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
- 4.The COVID-19 pandemic outbreak and measures to curtail it has caused significant disturbances and slowdown of economic activities. Consequently, the Company's manufacturing operations has been scaled down during the disturbance period. Non-availability of workers has impacted the prodcution level significantly. The Company has considered the possible impacts of known events arising from the still unfolding COVID-19 pandemic in preparation of the financial results. The impact of the global health pandemic may be different from that estimated as at the date of approval of these financial results and the Company will continue to closely monitor any material changes to the future economic conditions.
- 5. After the preparation of audited accounts for the financial year 2019-20, the Company has opted to apply concessional rate of taxation as per the provisions of Section 115BAA of the Income Tax Act, 1961 for financial year 2019-20 also before approval of these results. Accordingly, the provision for Income Tax and Deferred Tax balances have been recorded/re-measured for the current financial year using the new tax rate and the resultant impact is recognised in the above financial results. However, the change in provision for taxation for the financial year 2019-20 due to exercising the option shall be recognised in accounts after filing of the Income tax return.
- 6. Provision for Gratuity on actuarial basis as required under Ind AS 19 will be made at the end of the year.
- 7. The previous period figures have been regrouped/re-classified to make them comparable to the current period presentation.
