Gist of Proceedings of the 109th Annual General Meeting of The Ganges Manufacturing Company Limited

1. Date and Time of the Meeting

The 109th Annual General Meeting of the Company was held today i.e. on Tuesday, 16th September 2025 through video conferencing and other audio visual means. The meeting commenced at 11:00 a.m. The meeting got closed at 11:19 a.m. on the same day.

2. Brief details of items deliberated at the Meeting and result thereof

- Mr. Ravindra Kumar Poddar, Chairman, chaired the proceedings of the Meeting.
- The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman informed that remote e-voting commenced at 9:00 a.m. on 13th September 2025 and ended at 5:00 p.m. on 15th September 2025. Facility for e - voting during AGM was also provided.
- The following items of business as set out in the Notice calling the Meeting were put for Shareholders' approval:

Ordinary Business

- (i) Consideration and adoption of Audited Accounts of the Company for the year ended 31st March 2025 along with Auditors' Report and Directors' Report thereon;
- (ii) Re-appointment of Mr. Sanjay Kumar Thirani (DIN No-00248842), a Director who retires by rotation and being eligible, offers himself for re-appointment.

Special Business

- (iii) Appointment of Secretarial Auditor Mr. Babu Lal Patni, Practising Companies Secretary (FCS : 2304, COP : 1321) for term of five consecutive years commencing from 1st April 2025 to 31st March 2030.
- (iv) Ratification of remuneration and Appointment of M/s D. Radhakrishnan & Co., Cost Accountants (Registration No. 000018) to conduct an audit of the cost accounting for the financial year ending 31st March, 2026.
- (v) Re-appointment of Mr. Ravindra Kumar Poddar (DIN:00240643) as the Joint Managing Director of the Company, designated as the Executive Chairman of the Company, for a term of further 3 (Three) years with effect from 01st October, 2025.
- (vi) Re-appointment of Mr. Sanjay Kumar Osatwal (DIN:00248585) as the Joint Managing Director of the Company, designated as the Managing Director of the Company, for a term of further 3 (Three) years with effect from 01st October, 2025.
- The Chairman informed the members that Mr. Babu Lal Patni (FCS 2304), Practicing Company Secretary was appointed as the scrutinizer for the purpose of scrutinizing the remote e-voting and e-voting during AGM.
